- 1. The 41st AGM will be conducted on a virtual basis through live streaming and online remote voting using the Remote Participation and Electronic Voting ("RPEV") facilities to be provided by Company's Share Registrar, Boardroom Share Registrars Sdn Bhd, at https://meeting.boardroomlimited.my (Domain Registration No. with MYNIC – D6A357657). Please follow the procedures provided in the Administrative Guide for the 41st AGM in order to register, participate and vote remotely via the RPEV facilities.
  - The Administrative Guide on the conduct of a virtual 41st AGM of the Company is available at the Company's website at <a href="www.khj-my.com">www.khj-my.com</a>.
- The Broadcast Venue is strictly for the purpose of complying with Section 327(2) of the Companies Act 2016 which requires the Chairman of the Meeting to be present at the main venue of the general meeting and in accordance with Clause 66 of the Company's Constitution which allows a meeting of members to be held at more than one venue, using any technology or method that enables the members of the Company to participate at the general meeting. Members/proxies/corporate representatives are not allowed to physically present nor admitted at the Broadcast Venue on the day of the 41st AGM.
- Since the 41st AGM will be conducted virtually in its entirety, a Member entitled to participate and vote at the Meeting may appoint his/her proxy or the Chairman of the 41st AGM as his/her proxy and indicate the voting instruction in the Form of Proxy.

- 4. A proxy may but need not be a member. A member shall be entitled to appoint not more than two (2) proxies to attend and vote at the same meeting. Where a member appoints more than one (1) proxy, the appointment shall be invalid unless he specifies the proportions of his holdings to be represented by each proxy.
- 5. Where a member is an Exempt Authorised Nominee which holds ordinary shares in the Company for multiple beneficial owners in one securities account ("omnibus account"), there is no limit to the number of proxies which the Exempt Authorised Nominee may appoint in respect of each omnibus account it holds.
- 6. If the appointor is a corporation, this form must be executed under the corporation's common seal or under the hand of an officer or attorney duly authorised.
- 7. The appointment of proxy may be made in a hardcopy form or by electronic means, not less than forty-eight (48) hours before the time for holding the 41st AGM or at any adjournment thereof, as follows:
  - (i) In Hardcopy Form

The duly signed Form of Proxy or the Power of Attorney or other authority, if any, under which it is signed or a notarially certified copy of that power or authority, must be deposited at the Share Registrar's office, Boardroom Share Registrars Sdn Bhd at 11<sup>th</sup> Floor, Menara Symphony, No. 5, Jalan Prof. Khoo Kay Kim, Seksyen 13, 46200 Petaling Jaya, Selangor Darul Ehsan, Malaysia.

  - The Form of Proxy can be electronically submitted via the Share Registrars' website, Boardroom Smart Investor Online Portal at https://investor.boardroomlimited.com. Please refer to the Administrative Guide for the 41st AGM for further information on electronic submission.
- 8. Individual members may via Boardroom Smart Investor Online Portal at https://investor.boardroomlimited.com and proxies/corporate representatives may, via bsr.helpdesk@boardroomlimited.com, submit questions relating to the resolutions to be tabled at the 41st AGM or financial performance/prospects of the Company, not later than Wednesday, 25 May 2022 at 10.00 a.m. Alternatively, members/proxies/corporate representatives may submit questions via real time submission of typed texts via RPEV facilities during the live streaming of the 41st AGM, being the primary mode of communication.
- In respect of deposited securities, only members whose names appear on the Record of Depositors on Friday, 20 May 2022 (General Meeting Record of Depositors) shall be eligible to attend, speak and vote at the meeting or appoint proxy(ies) to attend and/or vote on his behalf.
